

Absentee Auction Bidder Rules

If you are unable to attend A Night for Sight on Saturday, May 22, you will be able to place an absentee bid by following the steps below:

1. The official A Night for Sight Absentee Bid Form must be completed in full for the auctioneer to accept your absentee bid. The form has instructions on it that must be followed completely and accurately.
2. Please pay particular attention to the General Bidding Increments rules. All lots will be bought for the lowest possible price based on the Auctioneer's bid increments.
3. Your bid MUST be received by FRIDAY, MAY 21 at 5:00 PM EDT at the A Night for Sight office located at 29201 Telegraph Rd, Site 324, Southfield, MI 48034
4. You must include a credit card number, name, address, telephone number and signature.
5. The Auctioneer will have the sole and final authority in awarding the sale of all lots.
6. If you are the winning bidder, your credit card will be charged at the conclusion of the auction.
7. Any tied final bids involving absentee bids shall be awarded to the onsite live bidder.
8. You will be notified of your winning bid the following work week by A Night for Sight.
